Sub: Fresh Composite Provisional Affiliation to the above said school upto Senior Secondary Level (A case of Switch Over from State Board to CBSE)

With reference to your application dated 07.06.2007 and subsequent correspondence with the school/inspection in this regard, I am directed to convey the sanction for Provisional Affiliation for Secondary School Examination/ Senior Secondary School Examination of the Board for a period of three years w.e.f. 01.04.2008 to 31.03.2011 in the following subjects: -

ENGLISH CORE, ECONOMICS, MATHEMATICS, PHYSICS, CHEMISTRY, BUSINESS STUDIES, ACCOUNTANCY, COMPUTER SCIENCE.

The above sanction is subject to the fulfillment of the following conditions: -

1. The school will follow the syllabus on the basis of curriculum prescribed by NCERT for the Middle Classes.
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
3. The school shall appoint only qualified and eligible staff.
4. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
5. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required.
6. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.
7. The school will provide Laboratories, Library and other facilities as per norms of the Board.
8. The school will abide itself by the conditions of affiliation already prescribed by the State Government concerned.
9. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
10. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
11. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

12. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
13. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
14. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
15. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
16. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
17. The affiliation Code Number allotted to your school is 1730333. This may please be noted and quoted for any correspondence with the Board.
18. Annual fee Rs. 4500/- @ Rs.1500/- per annum for the year(s) (1.04.2008 to 31.03.2011) be also remitted at an early date.
19. The school should apply for further Extension of Provisional Affiliation before 30th June of the preceding year before the expiry of the date of Affiliation 'On Line' through CBSE Website www.cbseaff.nic.in or www.cbse.nic.in and send a copy of its confirmation page with prescribed fee of Rs. 12,500/- in the shape of Bank Draft drawn in favour of Secretary, CBSE, Delhi.
20. Renewal of Registration of Society be ensured.
21. The school shall be eligible to start Class-IX and Class-XI w.e.f. the academic session 2008-09 and accordingly its first batch of Class-X and Class-XII would appear at AISSE/AISSCE to be held in March, 2010.
22. The school is required to withdraw its affiliation from the State Board as dual affiliation is not permissible. Also State Board Class-IX/XI will not be continued w.e.f. 01/04/2008. However for the 2008 & 2009 exam of X/XII the school will sponsor its students for State Board only.
23. The school has to make its own arrangement to sponsor its State Pattern classes which were running prior to the affiliation from the CBSE at respective examination conducted by the State Education Board.
24. The school is required to appoint only trained and qualified teachers on regular basis.
25. The school is required to pay prescribed grades of pay and other admissible allowances to its staff at par with the State Government Pay Scales.
26. The school Library should be spacious with more reference books to cater the needs of children.
27. The Laboratories in the school have no sufficient equipments. Hence, the school is required to upgrade the laboratories with sufficient equipments as per CBSE norms.
28. Computer Lab of the school is required to be expanded.

Definite compliance report along with supporting documents should reach the Board within 30 days failing which action will be inflated against the School
